- proof that you have comprehensive sickness insurance cover in Austria
- proof that you have sufficient resources for yourself and your family members for your planned stay in Austria.

- a proof that you have lived in Austria for the last 5 years and that you are still living in Austria
- Proof that you have been a family member of an EEA citizen or Swiss citizen for the last 5 years.

Even if you have already submitted all the listed documents, the authority may still require more information/documents from you. This may be necessary if not everything is clear for the authority yet. Therefore, please send these documents to the authority quickly.

If you do not pay the fees, you cannot get a residence permit. Please pay the fees as soon as possible. If you pay later, your procedure will take longer.
