## J. Which documents do you need for the application?

- Valid travel document, e.g. a passport.
- Birth certificate  
**You only need the birth certificate for the first application.**
- Photo of yourself (see point 1 of this explanation).
- Certificate of marriage or a partner certificate, if that applies.
- Document about your divorce or dissolution of your registered partnership, if that applies.
- Document about the adoption, if that applies
- Proof or document about the family relationship  
If you want to prove that a person is related to you, you must bring a confirmation.
- Death certificate, if that applies.
- Proof about sufficient health insurance in Austria.
- Proof that you have sufficient income.  
For example a work contract, a pay slip or a confirmation that you receive a pension.  
It may also be a proof that you own property.

For your first application as a **student** you need a letter of acceptance from the institution you wish you study at. Acceptable are letters of acceptance from

- the university (Universtität)
- the polytechnic institute (Fachhochschule)
- the accredited private university (akkreditierten Privatuniversität)
- the public or accredited teachers college (Pädagogischen Hochschule)

When applying for a **continuation of your residence permit** as a student, because you wish to continue your studies, you need:

- conformation, of being allowed to continue your studies
- proof of successful studies in the last academic year (Studienerfolgsnachweis).

When applying for a **continuation of your residence permit** as an extraordinary student (**außerordentlicher Student**), because you are in a University Preparation Programm preparing for supplementary examination(s) (Ergänzungsprüfung), you need:

- conformation, of being allowed to continue your studies
- proof of successful studies in the last academic year (Studienerfolgsnachweis)
- proof of admission to regular studies within two

If you covered by Union or multilateral programmes that comprise mobility measures or by an agreement between two or more higher education institutions, you must show proof of this fact. In this case your residence permit can be granted for up to two years.

When applying for a **continuation of your residence permit** as a student, because you need to participated in a **compulsory training** after finishing your studies, you need:

- conformation of the successful finishing of your studies at a
  - university (Universtität)
  - polytechnic institute (Fachhochschule)
  - accredited private university (akkreditierten Privatuniversität)
  - public or accredited teachers college (Pädagogischen Hochschule)
- confirmation of acceptance into a compulsory training provided for in law.

When applying for a **continuation of your residence permit** as a student while you are completing **compulsory training** after finishing your studies, you need:

- proof of adequate progress in the compulsory training.

When applying for a **continuation of your residence permit** as a student while searching for a job after finishing your studies, you need:

- conformation of the successful finishing of your studies in Austria at a
  - university (Universtität)
  - polytechnic institute (Fachhochschule)
  - accredited private university (akkreditierten Privatuniversität)
  - public or accredited teachers college (Pädagogischen Hochschule)

As a student you may also provide a **liability declaration** (Haftungserklärung).
