

Explanation of the application form

Stay Permit – Student

This explanation was intentionally written in easily understandable language.

This explanation is for your information only. Only the law published in German language is legally valid and binding. This means that you cannot derive any rights from this explanation.

You may only tick one box under "Application for a residence permit".

1. EU passport photo	The passport photograph has to be 35 millimetres wide and 45 millimetres high. You can find the exact dimensions here: www.bmi.gv.at/passbild .
2. Signature	You have to sign directly in front of the employee of the Austrian authority or Austrian embassy.
3.	You are not allowed to write anything here.

Type of application	You may only tick one application type (= one box) here.
4. Initial application	Tick this box if you currently do not have a residence permit for Austria.
5. Extension application	Tick this box if your residence permit is still valid and you are already holding the right purpose for your stay and you want to renew it. The purpose of your stay is for example your studies at a university or family reunification. You can apply when there are only 3 months left until your residence permit expires.
6. Application for change of purpose	Tick this box if your residence permit is still valid and you want to stay in Austria for a different purpose than the one you currently have. If you do not get the other purpose of residence, you will again get the same purpose of residence as before, if it is no longer valid. However, you must meet all the requirements for this.
7. Extension application/Application for change of purpose	Tick this box if you want to continue staying in Austria for a different purpose than the one you currently have AND you want to renew your residence permit if your change of purpose is denied. In this case, you will have to pay double the application fee.

The person must also pay for the costs incurred by a territorial authority if, for example, you do not leave Austria voluntarily despite a return decision, expulsion or a residence ban. A territorial authority is, for example, the federal government, state or municipality.</p> <p>The declaration of liability is valid for five years and must be certified by an Austrian notary or domestic court.</p> <p>The declaration of liability is possible with:</p> <ul style="list-style-type: none"> - "Settlement Permit – Artist" - "Settlement Permit" according to § 56 NAG - "Residence Permit – Pupil" - "Residence Permit – Student" <p>The declaration of liability is mandatory for:</p> <ul style="list-style-type: none"> "Settlement Permit – Dependent" "Stay Permit – Volunteers" <p>You can find a declaration of liability at https://bmi.gv.at/312/60a/start.aspx (only in German).</p>

Which documents do you need for the application?

- Valid travel document, e.g. a passport.
- Photo of yourself (see point 1 of this explanation).

- A document stating whether you have been convicted by a court. You can get this document for example from the police or from a court in your home country.
You only need this document for the initial application.
- Certificate of marriage or a partner certificate, if that applies.
- Document about your divorce or dissolution of your registered partnership, if that applies.
- Proof or document of relationship.
If you want to prove that a person is related to you (for example: your child), you must bring a confirmation. This is, for example, a birth certificate or an adoption certificate. In all other cases, you do not need to present a birth certificate.
- Death certificate, if that applies. If a person in your family has died (for example, your wife or husband).
- Proof about sufficient health insurance in Austria.
- Proof that you have sufficient income.
For example a work contract, a pay slip or a confirmation that you receive a pension. It may also be a proof that you own property. Das gilt wieder nur für Studenten bitte nicht mitkopieren!
- As a student, you also need to include information about the costs for your accommodation and proof (housing agreement [Wohnrechtsvereinbarung], rental contract, student-housing contract...).

For your first application as a **student** you need a letter of acceptance from the institution you wish you study at. Acceptable are letters of acceptance from

- the university (Universität)
- the polytechnic institute (Fachhochschule)
- the accredited private university (akkreditierte Privatuniversität)
- the public or accredited teachers college (Pädagogische Hochschule)

To pick up your residence permit (first application) in Austria you need

- A confirmation that you are enrolled for studies. This is, for example, a study sheet or a confirmation of enrollment.
- A proof of sufficient health insurance in Austria, if you have only presented a travel insurance so far. This is, for example, a self-insurance for students with the Österreichischen Gesundheitskasse or a private health insurance.

When applying for a **continuation of your residence permit** as a student, because you wish to continue your studies, you need:

- confirmation, of being allowed to continue your studies
- proof of successful studies in the last academic year (Studienerfolgsnachweis).

When applying for a **continuation of your residence permit** as an extraordinary student (**außerordentlicher Student**), because you are in a University Preparation Programm preparing for supplementary examination(s) (Ergänzungsprüfung), you need:

- conformation, of being allowed to continue your studies
- proof of successful studies in the last academic year (Studienerfolgsnachweis)
- proof of admission to regular studies within two

If you covered by Union or multilateral programmes that comprise mobility measures or by an agreement between two or more higher education institutions, you must show proof of this fact. In this case your residence permit can be granted for up to two years.

When applying for a **continuation of your residence permit** as a student, because you need to participate in a **compulsory training** after finishing your studies, you need:

- conformation of the successful finishing of your studies at a
 - university (Universität)
 - polytechnic institute (Fachhochschule)
 - accredited private university (akkreditierte Privatuniversität)
 - public or accredited teachers college (Pädagogische Hochschule)
- confirmation of acceptance into a compulsory training provided for in law.

When applying for a **continuation of your residence permit** as a student while you are completing **compulsory training** you need:

- proof of adequate progress in the compulsory training.

When applying for a **continuation of your residence permit** as a student while **searching for a job** after finishing your studies, you need:

- conformation of the successful finishing of your studies in Austria at a
 - university (Universität)
 - polytechnic institute (Fachhochschule)
 - accredited private university (akkreditierte Privatuniversität)
 - public or accredited teachers college (Pädagogische Hochschule)

As a student you may also provide a **declaration of liability** (Haftungserklärung).

ATTENTION:

Even if you have already submitted all the listed documents, the authority may still require more information/documents from you. This may be necessary if not everything is clear for the authority yet. Therefore, please send these documents to the authority quickly.

If you do not pay the fees, you cannot get a residence permit. Please pay the fees as soon as possible. If you pay later, your procedure will take longer.
